Federation-Entry Agreement

By entering a Federation-Licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor, or Longeur and on behalf of myself and my principal's, representatives, employers and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation Inc. (the "Federation") and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules and agree to release and hold nameless the competition affiliate organizations, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry the Federation and/or the competition may use or assign photographs, videos, audios, cablecasts, or other likeness of me and my horse taken during the course of the competition for the promotion coverage or benefit of the competition sport of the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity or to misappropriation. The construction and application of the Federation Rules are governed by the laws of the State of New York and any action instituted against the Federation must be filed in New York State. See Act 1502.5. US Equestrian Federation Release, Assumption of Risk, Waiver and Indemnification.

This document waives important legal rights. Read carefully before signing.

I AGREE in consideration for my participation in this Competition to the following:

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaultor, longeur, lessee, owner, agent, coach, trainer, or as a parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering or even death. ("Harm").

I AGREE to release the Federation, any affiliate organizations, NEHC, CHSA, CHJA, M&S, and the Competition from all claims or money damages or otherwise for any Harm to me or my horse and for any harm caused by me or my horse to others even if the Harm resulted directly or indirectly from negligence of the Federation of the Competition.

I have read the Federation Rules about protective equipment, including GR318 and EV113 and I understand that I am entitled to wear protective equipment without penalty and I acknowledge that the Federation strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all the obligations of this Release on the child's behalf.

I AGREE that "the Federation" and "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers, and affiliated organizations.

I AGREE that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Federation on the official USEF accident injury report form.
